Satisfaction survey results – PhD programme in VETERINARY AND ANIMAL SCIENCE

Number of questionnaires collected: 5

With a view to helping universities develop a system for monitoring processes and results of their teaching, research and third-mission/social impact activities, as well as of their actions aimed at taking into account the voices of PhD candidates, the Italian National Agency for the Evaluation of Universities and Research Institutes (ANVUR) has created a questionnaire template to collect the opinions of PhD students and graduates.

The questionnaire has two sections, A and B.

Section A consists of a set of close-ended questions, for which respondents choose one or more answers from the ones provided.

Section B consists of a list of statements; respondents rate their level of agreement with each statement on a scale from 1 to 10, where 1 equals “completely disagree” and 10 equals “completely agree”.

This report shows the results filtered by year of enrolment, as well as considered together. Each question of section A shows the number and percentage of answers given for each option. For each statement of section B, the report displays the average level of agreement.

In section B, the average level of agreement is represented by different colours:

- average level of agreement < 6 red ●
- average level of agreement $6 \leq X < 7$ yellow ●
- average level of agreement ≥ 7 green ●

These colours do not imply any judgement, but are included with the sole aim of highlighting critical and/or more than positive results.
